

## Northwest Region – Thunder Bay Satellite Courts Adjournment Dates for Criminal Appearances

**NOTE:** These dates are subject to change further due to the COVID-19 pandemic. Please check back on the [Ontario Court of Justice website](#) before your next court date, in case that date changes.

**Interim audio dates** In light of the ongoing COVID-19 situation, fly-in satellite courts will not be taking place from April to November 2020. Because some of these communities have a long gap before their next scheduled court date, we have scheduled interim audio court dates for each. The purpose of the interim audio date is to permit an earlier first appearance date for new charges, to generate disclosure and Legal Aid applications etc. It will also be an opportunity for guilty pleas or other resolutions (such as peace bonds, stays or withdrawals) prior to the next scheduled full court date. Otherwise, people are welcome to be remanded to the next full court date.

The audio court will be heard in plea court from Thunder Bay, by having the community call into the appropriate teleconference line, until November 29, 2020.
