## **National Day for Truth and Reconciliation September 30, 2022 – Criminal Matters**

September 30, 2022 is the second National Day for Truth and Reconciliation, a day to reflect on the ongoing impact of the residential school system in Canada and to honour survivors, their families, and communities. This is an important opportunity to acknowledge these experiences as part of the reconciliation process.

**At the Ontario Court of Justice, only Weekend and Statutory Holiday (bail courts) will operate on Friday, September 30, 2022. See the public statement by Ontario's three Chief Justices here: <https://www.ontariocourts.ca/en/public-statement.htm>.**

If you have a criminal matter that is scheduled for September 30, 2022, your matter will either be rescheduled in advance of September 30 or your matter will be given a new court date on September 30. If you have a lawyer and you are unsure if your matter has been rescheduled in advance of September 30, please contact your lawyer.

If your matter has not been rescheduled in advance of September 30, 2022 you can obtain your new court date by attending court on September 30 and speaking to your matter.
