## September 30, 2021 – Criminal Case Adjournment Dates

The Ontario Court of Justice will be closed on Thursday September 30, 2021 in recognition of the National Day for Truth and Reconciliation. See the public statement by Ontario's three Chief Justices [here](#) and the Ontario Court of Justice's Notice regarding the closure's impact on criminal, family, and Provincial Offences Act (POA) matters [here](#).

If you have a criminal court appearance on September 30, 2021 **do not attend court**. Your matter will be presumptively adjourned to another court date. The court will adjourn your matter without you being present, using a court order called a "bench warrant with discretion". The chart below sets out the new court date your matter will be adjourned to, depending on the courthouse where your matter is located.
