(b) Bringing the accused into the court at which they are required to appear at any time the court is sitting and giving the accused into the custody of the court. (c) Bringing the accused person to court with another proposed surety and asking for an order removing me as the surety and appointing the other person as the surety. I understand that I will remain responsible for the accused person until the new surety signs the release order.
