**In-person criminal case management appearances in Timmins**

Health and safety measures have been implemented in Timmins to permit personal attendance in exceptional circumstances. You will need to answer screening questions before you enter an Ontario courthouse. Based on your answers, you will be told whether or not you can enter. If you cannot enter, you will be told what to do next. You can complete the online screening before going to court. You must show the result as you enter. The online screening tool may be found at <https://covid-19.ontario.ca/courthouse-screening>. If you cannot complete the screening online, other screening options are available at the courthouse.

Face coverings are mandatory for everyone who is in a courthouse. If you do not have a face covering with you, you will be given one to put on before entering the courthouse. Persons with a valid medical reason for not wearing a face covering will not be required to wear one.
