

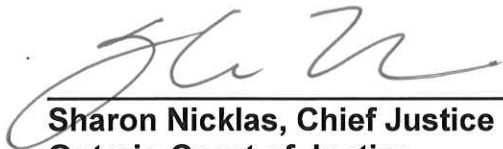
ONTARIO COURT OF JUSTICE
